The **Wonser Family** would like to **thank** all of our friends, family, & **ministry partners** who have **faithfully prayed** for & **encouraged** us **during** our **journey of faith**. You have **uplifted & challenged** our family to pursue **God** with all of our hearts & listen to the voice of the **Holy Spirit**, concerning our future. We have **watched God work** in **unexplainable** avenues **both** in the **Philippines**, and in **America**. It is **because of your love, prayer, & constant support** that our **passion for Christ** burns **hotter** than it ever has.

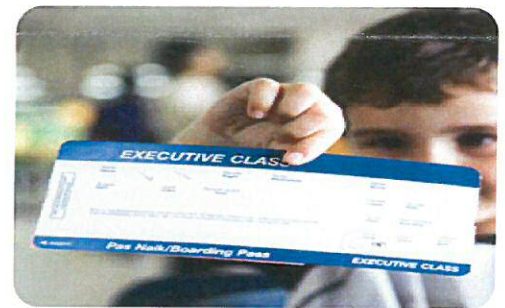
The **Holy Spirit** has **led** our family to **return** to **Cebu** and **continue** reaching **Cebuanos** with the **Gospel of Jesus Christ**. If the **Lord** does not **call His children home**, we will board a **Korean Airline** flight **February 9th** and **return** to the **mission field** God has **called** our family to. This has not been an **easy decision**, but we are **trusting God** by **faith** that **He** will be both our **protector** and **guide**. Thank you for **allowing** our family time to **pray** and **follow the leadership** of the **Holy Spirit** in our **lives**.

Two weeks after our arrival in **Cebu**, we will have the **privilege** of **hosting** a **team of 13 men and women** from **Echoes of Mercy Baptist Church** in **Cleveland, TN**. **Pastor Daniel White** brought **7 people** from his church to **Cebu** last **February 2015**. We were able to **work @** the **Philippine Dream Center**, **distribute thousands of Bibles**, **preach, sing, & see many people trust Christ** as their **Saviour** during their last visit. Please **pray** that **God** will **use their church** in an **amazing way** and **that many Cebuanos** will be **led to Christ** during their visit.

As we **return to Cebu**, we will need to **renew** our **missionary visas**. Please **pray** that **God** will **provide the funds** needed for our visas. The **total cost for our two year visas** will be **\$2,800**. This amount will need to be **paid by March 2016** for us to **continue serving the Lord** in **Cebu**. We are still **praying for God** to **provide** for the **extra bills incurred** during our trip to **Cebu** for **Victoria's arraignment**. A few **churches** have **taken special offerings** to help with **attorney fees and travel expenses**. The **remaining need for those extra expenses** is **\$2,200**.

Our family is **excited** about **returning** to **Cebu** and **continuing** the **ministry** God has **entrusted** us with. We ask that you **pray** for **daily protection** in our lives. We are **claiming God's promise** to us in **Isaiah 41:10** "**Fear thou not; for I am with thee; be not dismayed; for I am thy God; I will strengthen thee; yea, I will help thee; yea, I will uphold thee with the right hand of my righteousness**".

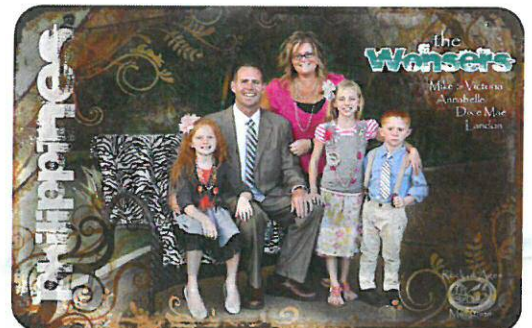
Please pray for the family we will leave behind when we board our flight on February 9th
